## **Med MoU on PSC Launches New Online Platform for Transparency and Knowledge Sharing**

*Public Access to Summaries of Detention Review Panel Cases Now Available*

The Secretariat of the Mediterranean Memorandum of Understanding on Port State Control (Med MoU) is pleased to announce the successful launch of a new dedicated webpage, providing controlled public access to anonymized summaries of Detention Review Panel cases. This initiative, developed in direct response to Decision PSCC26/16, marks a significant step forward in enhancing transparency, accountability, and knowledge sharing within the maritime community.

The newly launched platform allows researchers, maritime administrations, industry stakeholders, and the public to register as visitors and access detailed summaries of historical appeal cases. These documents offer invaluable insights into the detention review process, including the rationale behind the Panel's decisions, thereby promoting a deeper understanding of Port State Control (PSC) procedures and standards within the Mediterranean region.
